ASSUMPTION AND ACCEPTANCE OF RISK, RELEASE AND INDEMNITY**

I, _____, being aware that snowboarding, alpine, Nordic and freestyle skiing, tubing, mountain biking, horseback riding and such other recreational activities as Bolton Valley Resort may offer throughout the year are recreational activities carrying significant risk of serious personal injury, death or property damage and that there are natural, mechanical and environmental conditions and risks, which independently or in combination with such recreational activities may cause property damage, or physical injury, including severe or even fatal injuries to me or others, hereby **ASSUME** sole responsibility for such risks.

I also acknowledge that I am alone responsible for: (a) my safety while participating in any and all such recreational activities while on Bolton Valley Resort premises or when otherwise engaging in the use or enjoyment of said premises or while going to or from said premises; and (b) providing, utilizing and maintaining the equipment necessary for the safe enjoyment of my participation in such activities. In consideration for Bolton Valley Resort's permission to engage in any such activity, I hereby **RELEASE** and **HOLD HARMLESS** the owners and operators of the Bolton Valley Resort, including Mountain Operations and Development LLC., Redstone, and Bolton Valley Resort and their agents, representatives, officers, directors and employees in advance, from any and all liability whether foreseeable or unforeseeable resulting from my participation in any such activity, including any such claims regarding the design or condition of any equipment utilized by me in such pursuits without regard to whether such equipment is specified or recommended by such persons or entities identified herein.

To the extent I am also participating in any such activity which is promoted, sponsored or organized by any individual or entity other than those mentioned above, I also release any such promoter, sponsor, organizer, or club and their agents, representatives, officers, directors and employees from such liabilities and claims as well.

I further agree to forever **HOLD HARMLESS** and **INDEMNIFY** all person and entities identified above, generally and specifically from any and all liability for death, personal injury or property damage, resulting in any way from the aforementioned activities and uses or enjoyment.

I further agree that my privileges may be revoked by any representative or employee of the aforementioned persons and entities without refund at any time for misconduct, misuse, or nuisance.

I understand that it is my or my parent or guardian's sole and exclusive responsibility to provide valid and sufficient medical and accident insurance to cover medical or other injury or illness costs that may result from the aforementioned uses and enjoyment. I release all persons and entities identified above from providing this coverage for me.

I agree that I will accept and abide by the rules and regulations of the owners and operators of the Bolton Valley Resort and any other rules or regulations imposed by the promoters, sponsors and organizers of any particular activity. This Acknowledgment and Assumption of Risk and Release shall be binding upon my heirs and assigns.
